# PROCEEDINGS OF THE THIRD SESSION OF THE FIFTY-SIXTH SYNOD OF THE DIOCESE OF AUCKLAND

# FIRST DAY - FRIDAY 12 NOVEMBER 2021

### QUORUM

Members of Synod gathered online via Zoom meeting. The Diocesan Manager, Ms Sonia Maugham, certified that the requisite number of members were present to constitute the Synod.

The President of the Synod formally constituted the Synod at 8.37am. The Rt Rev'd Ross Bay presiding.

### **QUESTIONS**

Questions were asked by Mr Roger Williams (Parish of St Chad's, Meadowbank) and The Reverend Sandy Robertson (Diocesan School for Girls).

The President answered the questions of Mr Roger Williams and The Reverend Sandy Robertson. The President directed that the questions and answers be recorded in the Proceedings.

The questions and answers were as follows:

Mr Roger Williams: Standing resolution 50 states: "That the diocese of Auckland commits to carbon neutrality in its business, including its travel." Given this resolution passed in 2017, and the urgency of mitigating climate change by reducing carbon emissions, what actions have been taken to measure, reduce and mitigate carbon emissions of diocesan business, and across the diocese, over the last 4 years and where do opportunities exist to further progress towards this goal?

Answer: The Sustainability Fieldworker has been undertaking work towards this goal, including an examination of travel by diocesan staff.

This year the Diocesan Council adopted the Auckland Anglican Response to Climate Change Plan with actions for education, mitigation, worship and liturgy, and outreach and advocacy.

Among the actions for mitigation are:

• to provide resources to ministry units and encourage them to reduce their carbon footprint;

• to encourage and facilitate Diocesan staff, offices and ministry units to move towards renewable energy sources for their operations;

• to encourage carbon sequestration through tree planting; biochar burying; and regenerative gardening, horticultural and farming practices to increase the ability of the soil to act as a carbon sink.

Each ministry unit has been provided with a brochure summarising the plan which we will post in the Chat for members. A full version of the plan is available by contacting The Sustainability Fieldworker, Cathy Bi-Riley.

The Reverend Sandy Robertson: "What investigation has been or will be carried out within the Diocese regarding the sexual abuse of students at Dilworth School by former Dilworth Chaplain Ross Browne, including in relation to his move from Dilworth School to Manurewa parish?"

Answer: It is my intention to establish an independent review of these matters to ensure we understand what happened and what we can learn from it to prevent further abuse. The independence will be important as it will necessarily involve examination of actions and decisions of bishops. I will also comment on these matters in my Charge.

# SECOND DAY - SATURDAY 13 NOVEMBER 2021

## ANNOUNCEMENT

## <u>QUESTIONS</u>

Questions were asked by The Reverend Brenda Rockell (Parish of St John's, Royal Oak), on behalf of The Rev'd Joel Carpenter, The Rev'd Sarah West and Ms Cathy Bi-Riley, and The Reverend Clare Barrie (Parish of St Luke's, Mt Albert).

The President answered the questions of The Reverend Brenda Rockell and The Reverend Clare Barrie.

The questions and answers were as follows:

The Reverend Brenda Rockell: Is the Property Evaluation Working Group also being requested to take a strategic approach to Diocesan property assets in accordance with the 'he Waka eke noa' report to General Synod/Te Hinota Whanui? Is there further action that needs to be taken with the remit and resourcing of this group so it can fully explore the potential for social and affordable housing partnerships in this diocese?

Answer: The Property Evaluation Working Group has not been tasked with taking a strategic approach to diocesan property. Most property in the ownership of the Diocese is held in trust for ministry units and so such a strategic approach is constrained by the essential local control that exists. The Property Evaluation Working Group is available to lend its skills to ministry units that wish to consider repurposing land and property for other purposes such as social housing.

The report 'he Waka eke noa' is focussed on the trust funds held by the Church and invites Trustees to consider how they might be able to be applied for the purposes of impact investment. The General Trust Board which is the trustee for assets and funds held by our diocese has asked a sub-committee of trustees to consider what possibilities might exist to achieve this while taking account of beneficiary purposes and fiduciary responsibilities.

The Reverend Clare Barrie: Is the Development Fund no longer a mechanism for the Diocese to support ministry units wanting to address building issues? If not, what

mechanism does the Diocese have for funding building work across its portfolio? Will a review process of the initial funding rounds be undertaken to ensure that the process supports the aspirations of the Diocese for this funding?

Answer: Clare's question is prefaced with some background information about the development fund which I can't read out because the nature of synod questions is to ask a particular question. However the answer seeks to respond to what was submitted as a whole along with the specific questions.

In previous years the focus of the development fund was entirely on buildings. More recently and in response to requests from the diocese to see a wider range of development purposes fulfilled, Diocesan Council has widened its purpose to assist with the development of ministry initiatives, especially new initiatives.

Funding is still available for building projects where it is shown that the outcome of the work will enhance the mission and ministry purposes of the church. Some recent examples of this are the support of projects at Northwest, Flat Bush, Devonport, and St Luke's Mt Albert. However, the fund does not exist to attend to deferred maintenance on buildings. Improvements to existing buildings can be supported where there is a demonstration that this will greatly enhance existing ministry or allow the establishment of new ministry.

Diocesan Council annually reviews the criteria and processes related to the development fund to ensure it is meeting the aspirations of the diocese that funds be available to enable development.

Answer: In 2018 the Synod passed a motion within which it agreed to do all in its power to pledge regular financial assistance to Church Army. That is a call to the Diocese

as a whole and therefore to its ministry units and people. It was not a specific call on the diocesan budget and so it is hard to know what ongoing support there has been across the diocese.

In 2019, Diocesan Council made a donation of \$5,000 to Church Army New Zealand. Donations to various organisations are made from time to time by Diocesan Council in relation to its overall budget priorities.
