#### Membership

A quorum for all houses was present. The Diocesan Manager and Minute Secretary were also present. Members were asked to disclose any interests in relation to agenda items. Valonia Lawrence and Paul Woodfield were welcomed as new members of Diocesan Council.

Diocesan Council appointed the Rev'd Grant Robertson to the Finance Risk and Audit Committee as a Diocesan Council member.

Diocesan Council appointed Mr Andrew Maclean, Ms Angela Dalton, and the Rev'd Grant Robertson to the Working Group for the Independent Review of Centralised Accounting Services (Synod Motion 7).

#### St Andrew's Epsom – New Lease for Early Childhood Centre

A request was received from St Andrew's Epsom for Diocesan Council to support the parish entering into a new lease agreement for the Early Childhood Centre. This request was approved.

#### Parish of Clevedon – Lottery Environment and Heritage Funding Application
